5. Verify that your calculated charges include applicable minimums.
6. Note on your PO "Freight determined by Leland Freight Program".

**MINIMUM CHARGES**

- A \$95 minimum is applied to stacking chairs.
- A \$185 minimum is applied to non-stacking chairs and tables.
